Before proceeding, look at the question of whether some students might be exempt from withholding. Your resources for discussing this issue are the instructions for Form W-4 and handout 2A-1, Are You Exempt from Withholding which guides the reader step-by-step through the decision-making process. (Section C of the software supplement also addresses this issue.) Exempt students would complete only lines 1, 2, and 6 of Form W-4. 3. Next, students will have to think about the number of allowances they claim. You may use the worksheet on the front of Form W-4 or the optional software to help them. Explain that the additional worksheets on the back of Form W-4 are for the use of taxpayers in more complex situations. You may have students who should use the Two-Earner Two-Job Worksheet. A sample copy of the back of the form is supplied for you to share with such students. 4. In the course of counting their allowances, students may have to learn the meaning of dependent as it is used on federal tax forms. To help them, use student handout 2A-2, The Dependency Tests, which guides the reader through the five-part test for dependents. This dependency test is important in...
